<p style="text-align: center;"><b>PETITIONER'S MOTION FOR SUBSTITUTION OF LIQUIDATOR AND TO AMEND CAPTION</b></p>	

Pursuant to § 10-3-517(1), C.R.S., and this Court's Liquidation Order, Petitioner hereby moves this Court to substitute interim Insurance Commissioner Michael Conway as Liquidator of the Colorado Health Insurance Cooperative, Inc. ("CO-OP") and to amend the caption to reflect such substitution. As grounds therefor, Petitioner states as follows:

1. On January 4, 2016, this Court appointed Marguerite Salazar, the former Insurance Commissioner, to serve as Liquidator of the CO-OP pursuant to § 10-3-517(1), C.R.S.
2. On January 1, 2018, Governor John Hickenlooper appointed Michael Conway to serve as the interim Colorado Insurance Commissioner ("Commissioner") and to head the Colorado Division of Insurance.

WHEREFORE, pursuant to § 10-3-517(1), C.R.S., and this Court's Liquidation Order, the Petitioner requests that this Court enter an order substituting Michael Conway as Liquidator of the CO-OP and to restyling the caption in a form consistent with the proposed order submitted herewith.
