1 **ORDER APPROVING NINTH STATUS REPORT; MOTION TO DISTRIBUTE BALANCE OF**
2 **POLICYHOLDER (CLASS B) CLAIM AND ENTIRETY OF CLASS (E)**

3 The Plaintiff's NINTH STATUS REPORT; MOTION TO DISTRIBUTE BALANCE OF
4 POLICYHOLDER (CLASS B) CLAIM AND ENTIRETY OF CLASS (E) having been filed,
5 having been submitted to the Court, and the Court being fully informed in the premises and
6 good cause appearing, the Court now finds and ORDERS as follows:

- 7 1. Financial data from the Receiver's financial analysis of the receivership estate
8 actively support the release of the remainder of the sole policyholder class (b) claim
9 and sole state government class (e) claim. Adequate money has been retained to
10 pay claims under NRS 696B.420(1)(a).
11 2. The Receiver may distribute the remaining \$50,000 to the sole policyholder class
12 (b) claim.
13 3. The Receiver may distribute the \$550 class (e) claim to the State of Nevada,
14 Division of Insurance.

15 IT IS HEREBY ORDERED, pursuant to NRS 696B.420(1), the Receiver may distribute
16 the remaining \$50,000 class (b) claim, and \$550 class (e) claim.
